

## Second Annual Midwest Conference To Be Held Aug. 24-26 In Kansas City

Make plans now to attend the 2005 Midwest Conference on Problem Gambling and Substance Abuse Aug. 24-26 at the Hyatt Regency Crown Center in Kansas City. This second annual conference will feature national experts in the fields of problem gambling and substance abuse, as well as regional experts from throughout the Midwest, who will be sharing their best methods and practices.

Although planning is still underway, Melissa Stephens, problem gambling administrator with the Missouri Gaming Commission, said the Midwest Consortium on Problem Gambling, which is planning the conference, is working to ensure the conference will include workshops and general sessions that will benefit a wide range of individuals.

"We're working on setting up workshops that will focus on clinical applications, research, public policy, the gaming industry, gaming regulation and special populations," Stephens said. "We're very excited about the conference this year, and we're again pleased to be able to host it in Kansas

City. Hosting the conference gives Missouri residents and professionals the opportunity to attend a first-rate conference just a short drive from their homes."

## Web Site Makes Finding Area Counselors Easy

Certified compulsive gambling counselors (CCGC) are now on-line. The complete list of Missouri's CCGCs have been placed on the Alliance's Web site at [www.888BETSOFF.org](http://www.888BETSOFF.org).

"The list of the counselors offering services through the Missouri Department of Mental Health's Division of Alcohol and Drug Abuse has been on the site all along, but the list now includes all the certified counselors who wanted to be on the list," said Shelly Perez, responsible gaming coordinator for the Missouri Lottery and editor of the Web site.

Perez said the list is updated as she

receives changes from the Missouri Department of Mental Health.

According to Perez, the list is now easier to use, too.

"We organized the Web page with links to each county's list," she said. "Visitors to the Web site just need to click on their county or a county near them to find a list of the certified compulsive gambling counselors in that county.

"We hope the revisions to the list will make finding counselors easier for problem gamblers and their family members," she continued. "That's our ultimate goal."

## Programs, Events, Participation On The Increase

This is an exciting time for the Missouri Alliance to Curb Problem Gambling as our programs continue to grow, and we are serving more people than ever before. 1. Have you often gambled longer than you had planned?
2. Have you often gambled until your last dollar was gone?
3. Has gambling ever made your home life unhappy?
4. Do you ever lie to cover up your gambling activity?
5. Do you become restless or irritable when trying to cut back or stop gambling?
6. Have you ever broken the law or considered breaking the law to finance your gambling?
7. Do you rely on others for financial help and/or to finance your gambling?
8. Has your gambling ever caused you to be careless of the welfare of yourself or your family?
9. Do you gamble to escape problems or to feel better?
10. Have you ever gambled to get money with which to pay bills or otherwise solve financial difficulties?
11. After losing, have you ever gambled in attempt to win it back?
12. Have you ever considered self-destruction or suicide as a result of your gambling?

the Missouri Gaming Commission.

"We know there are many individuals worthy of receiving this award," Mullally continued. "This is a small way we can recognize some of the great work with problem gambling that is going on in Missouri."
