

Midwest Conference Provides Opportunity to Gather with Experts

Nationally renowned experts will highlight the sixth annual Midwest Conference on Problem Gambling and Substance Abuse Aug. 12-14 at the Hilton Frontenac in St. Louis.

Hosted by the Missouri Alliance to Curb Problem Gambling, the conference is also being sponsored by organizations throughout the four-state region – Missouri, Kansas, Iowa and Nebraska.

“We’re very excited about the approaching conference,” said Mike Winter, chairman of the Alliance. “This conference will present a great opportunity for people to become better informed about the significance of problem gambling and its impact on the community,” he continued.

The three-day conference will open on Aug. 12 with a keynote address from Dr. H. Westley Clark, U.S. Department of Health and Human Services, and conclude on Aug. 14 with post-conference training on ethics and clinical supervision.

Additional keynote speakers include Dr. Michael Flaherty, executive director for the Institute for Research, Education and Training in Addictions; Dr. Marc Potenza, problem gambling clinic director and associate professor at Yale University; and Ron Willis, mental health consultant and president of Green Porch Swing Productions.

In addition to informative and entertaining keynote speakers and programs on a variety of topics related to problem gambling and substance abuse, more than 12 continuing education credits will be offered. More information on continuing education credits will be made available in the coming weeks.

Additionally, an optional event, “Dinner and Music at the Magic House,” will take place on Aug. 13 from 6 to 10 p.m. in the new wing of the Magic House in St. Louis. With the help of sponsors, the cost of the optional event is \$25 per person through July 31, and \$50 if purchased after that date. The event includes roundtrip transportation, a buffet style dinner, a live band and museum exhibits. Additional tickets can be purchased for guests not attending the conference.

The cost of attending the conference is \$150 for early bird registration, \$180 for regular registration and \$220 for onsite registration. The student rate for attending the conference is \$75 for early bird, \$90 for regular registration and \$110 for onsite registration.

New Youth Addiction Prevention Program to be Released in August

The award-winning “Beat Addiction: Choose the Right Path” youth addiction prevention program, which was originally released in 2002 to more than 700 schools, will be re-released to more than 1,500 Missouri schools in August.

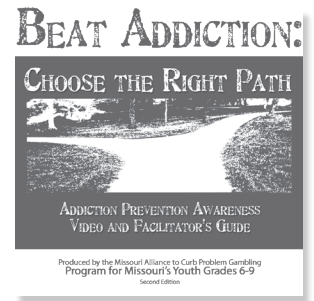
According to Frank Finley, video producer for the Missouri Lottery, the goal of the second version of “Beat Addiction” was not only to address the spectrum of addictive and compulsive behaviors, but to do so in a more realistic manner.

“Students that watched the first version of ‘Beat Addiction’ said they wanted to hear from people that were closer to their age. In the new version, we interviewed young addicts in recovery that were forced to overcome enormous obstacles,” said Finley.

The new version of “Beat Addiction” is recommended for students in grades 6-12, and it features four testimonials and re-enactments about teens that have battled various addictions including: gambling, marijuana, methamphetamine, cocaine, heroin and alcohol. The revised edition also includes the original program from 2002, which focuses on one woman and her family’s struggle with addiction.

The program was developed and produced by the Missouri Lottery for the Missouri Alliance to Curb Problem Gambling, in partnership with the Missouri Department of Elementary and Secondary Education (DESE). The program was evaluated and approved by DESE as a resource that meets DESE-established Show Me Goals (SMG) and Guidance Grade Level Expectations (GLE) in the category of Personal Social Development.

Voluntary Exclusion Program Helps Gamblers Curb Addiction

The Missouri Gaming Commission administers a voluntary exclusion program from Missouri’s casinos for problem gamblers.

This unique program, created in 1996, provides problem gamblers with a method to acknowledge that they have a gambling problem and take personal responsibility for it by agreeing to stop visiting casinos. The exclusion is for life.

Research indicates that problem gambling is a lifetime condition, and those who suffer from it are never “cured” but are constantly “recovering.”

Congressman Pushes to Let Americans Gamble Online

U.S. Rep. Barney Frank recently introduced legislation to allow Americans to gamble online.

According to Frank, who chairs the House Committee on Financial Services, he plans to unveil a plan to allow licensed gambling operators to accept bets from people in the United States. Industry insiders said the bill is likely to include provisions to deter compulsive and underage gambling, money laundering, fraud and identity theft.

The Safe and Secure Internet Gambling Initiative, a group that advocates the legalization of online gambling, estimates that millions of Americans wager more than \$100 billion a year through offshore gambling sites, despite the fact that it’s illegal under the Unlawful Internet Gambling Enforcement Act of 2006.

Frank introduced a bill to legalize online gambling in 2007, but the measure stalled. Opponents argue that children and adults would be at risk of compulsive gambling, fraud and identity theft if allowed to gamble online.

The Safe and Secure Internet Gambling Initiative estimates that the United States could collect up to \$62.7 billion in tax revenue during the next 10 years if online gambling were legal. The group, other proponents and Frank argue that people will gamble on the Internet whether or not it’s legal, and the government can better control activity and prevent related problems by legalizing online gambling.

Bets Off Web Site Directs Problem Gamblers to Help

The Missouri Alliance to Curb Problem Gambling-sponsored Bets Off Web site features a wealth of information about problem gambling including compulsive gambling warning signs. Exhibiting five or more of the following compulsive gambling symptoms may indicate a gambling problem:

- Frequent thoughts about past experiences, future plans or how to get money for gambling;
- Urges to increase spending in order to reach a high level of excitement;
- Failure to stop or control gambling;
- Restless and/or irritable feelings when attempting to cut back or stop gambling;
- Recurrent desires to "get even" after experiencing losses;
- Attempts to tell others lies about your gambling habits;
- Thoughts about engaging in illegal acts to finance gambling (or actual participation in illegal acts);
- Job, school or relationship problems due to gambling; and
- Tendency to rely on others for financial assistance.

If you have experienced any of the compulsive gambling symptoms or know anyone else who has, free problem gambling treatment is available. Information about treatment options in Missouri is accessible through the 24-hour toll-free problem gambling help line, 1-888-BETSOFF, or by visiting the Alliance's Web site at 888betsoff.org.

Free Help Available to Problem Gamblers and Families

The first step to overcoming a compulsive gambling disorder is admitting there is a problem and recognizing that it won't go away without help.

Free counseling for compulsive gamblers and their family members is provided through agencies contracted through the Missouri Department of Mental Health. A list of these agencies, along with a complete list of certified compulsive gambling counselors in Missouri, can be found online at http://www.888betsoff.org/alliance/CCGC_providers.shtm.

In addition to the Web site, help is available over the phone by calling the toll-free program-gambling help line at 1-888-BETSOFF.

According to Sue Self, vice president of Telephonic Counseling and program manager for the problem gambling help line, callers can now set the appointment with a certified compulsive gambling counselor without having to make a second call.

"We want to increase the likelihood of the caller getting into services," explained Self. "Often times, the caller just doesn't make that second call to set up an appointment for counseling. We're hoping that, doing it during their initial call for help, it might encourage them to show up."
